#### **EXECUTIVE SUMMARY**

During the period January – March 2023, twenty-one (21) Notices of Breach of Licence were issued to twenty (20) broadcast radio licensees and one (1) broadcast television licensee.

Forty-one (41) contacts were recorded for the period January – March 2023. Of this number, twenty-five (25) were complaints - twenty (20) broadcast radio and five (5) broadcast television - which resulted in investigations. Sixteen (16) were queries and comments about other operational issues pertaining to licensed operators and the work of the Commission.

All twenty-five (25) complaints were matters relating to content standards. There was an increase of four (4) when compared with the previous quarter, October– December 2022.

Regarding technical matters, monitoring of twenty-two (22) broadcast radio licensees was conducted to determine their coverage in the parish of St. Ann. The technical team also conducted follow-up signal leakage investigations in Kingston and St. Andrew, St. Catherine and St. Ann to validate the remedial actions taken by the subscriber television licensee responsible for the high signal leakages.

In relation to the payment of the annual licence fee, sixteen (16) subscriber television (STV) operators, or 40% of all licensees paid in full; five (5) or 13% made partial payments and nineteen (19) or 47% were non-compliant. There was an increase in the number of full payments when compared to the previous quarter. The number of licensees who made partial payments increased by two (2) and there was a decrease of three (3) in the number of non-compliant licensees.

#### INTRODUCTION

#### **Contacts with the Commission**

Forty-one (41) contacts were recorded for the period, January – March 2023. There were twenty-five (25) investigations and twenty-one (21) Notices of Breach of Licence.

#### PROGRAMMING CONTENT COMPLIANCE

The Commission investigated twenty-five (25) complaints relating to the broadcast of problematic content. The number of complaints investigated decreased by four (4) when compared to the previous quarter October to December 2022.

**Table 1** details the complaints investigated relating to content standards between January and March 2023, and the nature of the investigations conducted by the Commission.








Full Payment - 40%
