# EXECUTIVE SUMMARY BCJ- Quarterly Monitoring & Compliance Report (April – June 2015)

During the period April – June 2015, eleven (11) Notices of Breach of Licence were issued to five (5) broadcast radio licensees, three (3) broadcast television licensees and three (3) to subscriber television licensees. There was an increase of two (2) when compared with the previous quarter, January – March 2015.

One hundred and eighty two (182) contacts were recorded for the period April – June 2015. Of this number, fifteen (15) were complaints, which resulted in investigations of broadcast radio and television operators. One hundred and sixty seven (167) were queries or comments about other operational issues pertaining to licensed operators and the work of the Commission.

All fifteen (15) complaints were matters relating to content standards. There was an increase of nine (9) when compared with the previous quarter, January – March 2015.

Six (6) subscriber television licensees were inspected during the period under review, to determine their compliance with technical standards.

In relation to the payment of the annual licence fee, seventeen (17) subscriber television (STV) operators, or 41% of all licensees paid in full; eleven (11) or 26% made partial payments and fourteen(14) or 33% were non-compliant. There was an increase of one (1), in the number of full payments recorded when compared to the previous quarter. The number of licensees who made partial payments remained the same. However, there was a decrease of one (1) in the number of non-compliant licensees.

#### **INTRODUCTION**

#### **Contacts with the Commission**

One hundred and eighty two (182) contacts were recorded for the period, April – June 2015. There were fifteen (15) investigations and eleven (11) Notices of Breach of Licence were issued.

#### PROGRAMMING CONTENT COMPLIANCE

The Commission investigated fifteen (15) complaints relating to the broadcast of problematic content. This is an increase of nine (9) when compared to the preceding period January –March 2015.

**Table 1** details the complaints investigated relating to programming standards between April and June 2015 and the nature of the investigations conducted by the Commission.

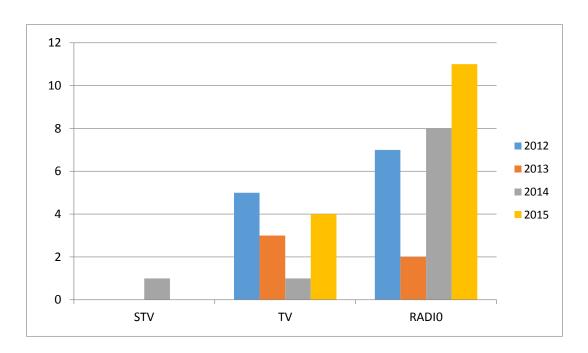

#### **TECHNICAL MONITORING**

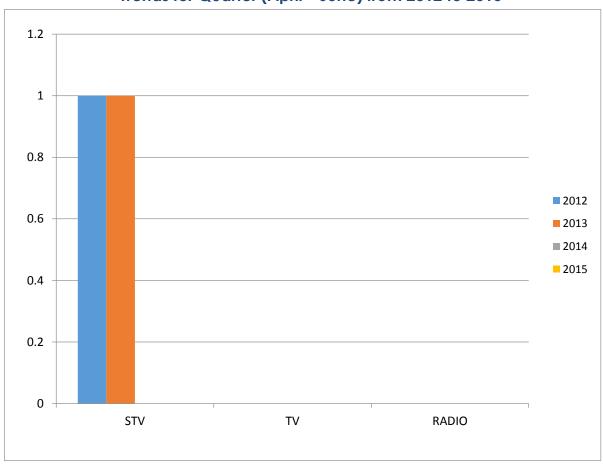

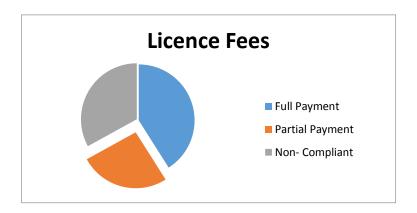

#### FINANCIAL COMPLIANCE

STV operators are required to pay an annual licence fee of five percent (5%) of their gross subscription income. Payment is made quarterly and is calculated using data from Quarterly Returns submitted by STV licensees.

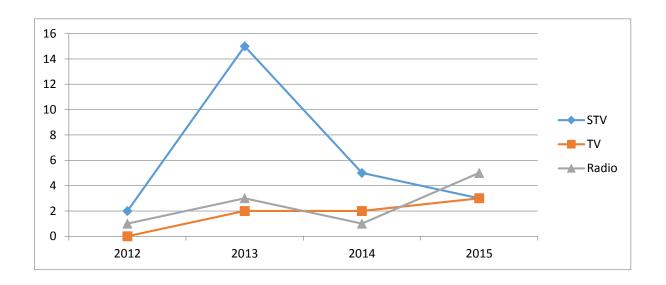
#### **NOTICES OF BREACH**
